 conference. They reported that it was a very beneficial conference and great opportunity
 to hear what is happening around the country with E Schools. It appears all e-schools are
 struggling with engagement, building community, and making connections.
- CCIP/OIP This is our Federal Funding Application. Rosemary and Steve work collaboratively to be sure we are up to date with this process.
- 22+ Program Seven students have graduated already this school year. We have six more nearing the end of their requirements at this time.
