Sponsor Update and Legal Update:

Ms. Krista Miller - Interim Superintendent of Findlay City Schools gave an update of the following Information:

- 1. SB 1: Reform Ohio Department of Education
- 2. SB 11: Parent Educational Freedom Act
- 3. SB 14: Veterans' Eligibility as Teachers
- 4. SB 17: Financial Literacy Education- Capitalism

Discussion Items:

- HB 123 Threat Assessment Training Rosemary, Michael and Amber attended this
 required training. it provided the process and guidelines to evaluate a student's
 threat. FDA will be reviewing information shared at the training and will sharing with
 the FDA staff.
- Enrollment Update We are currently in a brief "pause" for enrollment. Administration will continue to monitor applications to attend FDA and add will add students as the numbers of FDA students decrease through graduation. 38% of our students are from county schools. We have had 15 students graduate to date. 14 Students are in Millstream (5 Seniors, 9 Juniors) and we have 13 Sophomores applying for the next school year. 22% of students currently enrolled are identified as Students with a Disability.
- Update on School Audit Rosemary and Steve are working with state auditor to complete audit for FY'22.
- Climate Data (Exhibit I) This document was reviewed with the Board.
- FY'23 FTE Review- Scheduled for June 7, 2023. This is an annual requirement of the HB 123 pilot program.
- Special Education Services We currently have 41 students on an IEP. 27% of these students are from county schools. We are continuing to advertise and locate certified special education teachers to add to our staff.
- FDA Professional Development Day (February 20, 2023) Some items that will be featured at this meeting: Seth Butler will be presenting on Implicit Bias. Jessice Halsey will give a refresher on the use of AED and Narcan. We will hold our February Staff meeting. Additionally, we will visit NWO Orthopedics Center to learn about job opportunities for our students.
- Graduation May 27, 2023 Graduation is scheduled for this day and will once again
 be held at the Marathon Center for the Performing Arts. More detailed information will
 come as this date draws near. All Board members are encouraged to attend.
- Update on Pilot Program for DOPR E School (HB 123) We are currently in our second year of a three-year pilot program. This program has really benefited our school and helped us remain in the black. The final report that was prepared by the Ohio Department of Education has been shared with legislators. Rosemary is working with the GRADS Coalition to help move this model into the state budget for education.

- Digital Learning Annual Conference, February 13-15, 2023 This national conference is in Austin, Texas. We have 4 members from our BLT attending in person and 4 members attending virtually.
- CCIP/OIP Rosemary and Steve continue to update the federal monies as appropriate.
- 22+ Program Update We currently have a waiting list of about 20 adults. We have applied for an additional \$10,000.00 grant from ODE. We are expecting at least 3 graduates for Fy'23
- Board Policy Book Update Rosemary will be working with Brian DeSantis, Esq. to
 update our FDA Board Policies to make sure they are compliant. This will be done
 over the next several months.
